

FACTS WHAT DOES THE BLUESKY COMPANIES DO WITH YOUR PERSONAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and employment information
- income and payment history
- credit history and credit scores

How? All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons the BlueSky Companies chooses to share; and whether you can limit this sharing.

How does the Bluesky Companies, Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes—information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ <i>Our affiliates include companies with a "Bluesky" name; financial companies, such as Bluesky Financial Services, Inc.; and nonfinancial companies, such as Bluesky Marketing Group, Inc.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ <i>Nonaffiliates we share with can include financial service providers, motor vehicle manufacturers, motor vehicle dealers, insurance companies, aftermarket product providers, direct marketers, and retailers.</i>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ■ <i>The Bluesky Companies doesn't jointly market.</i>
Other important information	
<p>CALIFORNIA AND VERMONT RESIDENTS: We do not share information we collect about you with nonaffiliates for purposes other than our everyday business purposes.</p> <p>VERMONT RESIDENTS ONLY: We do not share information we collect about you with our affiliates for purposes other than marketing.</p>
